ENGINEER- REQUEST FOR QUALIFICATIONS

The Manville Water Supply Corporation (Manville) requests the submission of qualifications statements, which will lead to the possible award of a contract to provide consulting engineering services for a project involving treatment of PFAS and lithium at Manville Water Facilities.

Scope of Work

The services to be obtained for the **Engineer** include TWDB funding coordination/support, project management, planning, design, permitting, bidding, and construction phase services associated with water treatment for per- and polyfluoroalkyl substances (PFAS) and lithium treatment systems at multiple proposed treatment locations (see attached exhibit).

Guidelines for Content of Qualification Statements

DO NOT INCLUDE COST INFORMATION with the qualification statement. Responses that include cost or pricing information will be rejected and will not be considered by Manville.

Detailed instructions on the preparation of the qualification statement must be obtained from Manville. This information should be requested as soon as possible in order to allow time to prepare the document and comply with the procedures.

Submittal Deadline

Minimum Qualifications and Selection Criteria

Manyille will evaluate the proposals to determine which firm has the best qualifications.

Contract Terms and Negotiation Schedule


The consultant for engineering services is expected to negotiate an agreement for services that is acceptable to Manville. If an acceptable contract cannot be negotiated, Manville may formally end negotiations and begin negotiating with the next highest qualified person or firm.


This contract is contingent upon release of funds from the Texas Water Development Board (TWDB). Any contract or contracts awarded under this Request for Qualifications (RFQ) are expected to be funded in part by a 100% principal forgiveness loan from the TWDB. Neither the State of Texas nor any of its departments, agencies, or employees are or will be a party to this RFQ or any resulting contract.

RFQ's are issued in accordance with Section 2254 of the Texas Government Code (Professional Services Act).

This contract is subject to the Environmental Protection Agency's (EPA) Disadvantaged Business Enterprise (DBE) Program, which includes EPA-approved fair share goals toward procurement of Minority and Women-owned Business Enterprise (M/WBE) firms. EPA rules require that applicants and prime contractors make a good faith effort to award a fair share of contracts, subcontracts, and procurements to M/WBEs through demonstration of the six affirmative steps.
